GENERAL INFORMATION

PROTERIS DEFOAMER is a superior foam suppression and defoaming aid, even under agitation. PROTERIS DEFOAMER mixes quickly in cold water and is effective in both fertilizer and water based applications.

DIRECTIONS FOR USE

PROTERIS DEFOAMER's powerful formulation can be used as either an antifoam or defoamer

Antifoam: Use PROTERIS DEFOAMER to prevent foam formation by adding it to the spray solution first, while agitating, and before adding pesticides.

General Defoamer: Use PROTERIS DEFOAMER as a general defoamer by adding it to the spray solution during agitation while foam formation is active.

SHAKE WELL BEFORE USING.

NOT FOR AQUATIC USE. FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NONCROPLAND, ORNAMENTAL, RIGHTS-OF-WAY, TURF AND OTHER APPROPRIATE USES.

USE RATES

Antifoam: Use 0.5-2 ounces of PROTERIS DEFOAMER per 100 gallons of solution.

General Defoamer: Use 0.5-4 ounces of PROTERIS DEFOAMER per 100 gallons of solution.

MIXING:

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed
- AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- Dry soluble and suspension fertilizers / micronutrients.
- Liquid drift retardants and flowable formulations (F & FL)
- 5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- Finish filling to desired spray volume level and continue agitation

ENVIRONMENTAL HAZARDS

Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters.

STORAGE AND DISPOSAL
